Mr Ho also has a deemed interest in:

i) 6,800,000 BTH shares, of which 800,000 BTH shares are held by Raffles Nominees (Pte.) Limited (acting as nominee for KAP Holdings Ltd ("KAP")) and 6,000,000 BTH shares are held by Recourse Investments Ltd ("RI"). KAP is a wholly-owned subsidiary of RI, which is jointly owned by Mr Ho KwonPing and Ms Chiang See Ngoh.

ii) 286,519,882 BTH shares held by Bibace Investments Ltd ("BI"). BI is 48.81% held by Bibace Management Company Limited, acting as trustee of The Bibace Trust. Mr Ho KwonPing is a named beneficiary of The Bibace Trust.
